## **NOMINATION COMMITTEE ANNOUNCES CANDIDATES**

Pikes Peak Credit Union's Annual Meeting will be held on Saturday, May 18, 2024 at the DoubleTree by Hilton Hotel Colorado Springs at 11:30 am. The Nominating Committee has selected the three candidates listed below to fill Director positions that will expire in 2024. Members may apply by petition for a Director position. Nominations by petition must be signed by one percent (1%) of the members. An election by member ballot will be conducted only if one or more petitions are received by the deadline of January 31, 2024. If there are no nominees by petition, ballots will not be provided and the nominees listed within this notice will be declared elected at the Pikes Peak Credit Union Annual Meeting on May 18, 2024. Pikes Peak Credit Union's bylaws do not permit nominations from the floor at the Annual Meeting.

### **2024 Board of Directors Election Candidates**

#### **MIKE CLIETT (Incumbent)**

Mike Cliett has been a member of Pikes Peak Credit Union for 35 years. He was a member of the Supervisory Committee from 2000-2008 and was elected to the Board of Directors in 2008. He has held the position of Vice Chairperson since 2021. Mr. Cliett graduated from the University of Phoenix with a master's degree in Computer Information Systems

and also has a bachelor's degree in Industrial Management. Mr. Cliett's occupation is property investing.

#### **MARY KILLORAN (Incumbent)**

Mary Killoran joined Pikes Peak Credit Union after marrying into a postal worker's family and has since maintained her account for 43 years. She was elected to the Board of Directors in January 2021 to fill a vacancy created by the retirement of a long-term Board member. She previously served on Pikes Peak Credit Union's Supervisory Committee from 2017-2021, where she served as Secretary. Ms. Killoran spent her working career as a bookkeeper, elementary school teacher, legal secretary and law librarian. She is now retired and has the time to volunteer in the community.

#### **SAM WASHBURN**

Sam Washburn has been a member of Pikes Peak Credit Union for 37 years. She served on the Supervisory Committee from 2018 - 2023 and was elected to the Board of Directors in June 2023 to fill a vacancy. Ms. Washburn began her career with the FBI in 1978 and left in 1980 to finish her bachelor's degree. She graduated in 1983 with a BS in Sociology/Criminal Justice. She went on to work for the El Paso County Sheriff's Office for 26 years, attaining the rank of Division Commander. While there, she attained her Master's Degree in Police Administration from the University of Colorado Denver. She has learned so much on the Supervisory Committee and Board of Directors and would like to continue serving, if the membership allows.
