New Relationship Pricing on Auto Loans

We value your membership and want to reward our loyal members with discounted loan interest rates. You can lower your rate on a new auto loan by up to 0.75% APR* when you have the following services with PPCU:

1. 0.25% APR* off your auto loan interest rate if the primary borrower has a checking account at PPCU with payroll or retirement direct deposit.
2. 0.25% APR* off your auto loan interest rate if you enroll in automatic payments from a qualifying account at PPCU.
3. 0.25% APR* off your auto loan interest rate if you have a home equity loan at PPCU.

*APR = Annual Percentage Rate. Members can qualify for one, two or three of the discounts listed above. Discounts may not be combined with other promotional rates unless explicitly stated. All loans are subject to credit approval. Member must notify PPCU when conditions are met. Not valid on PPCU loans opened prior to August 1, 2025. To retain the discounted interest rate, all qualifying conditions must be continuously met throughout the loan term. Failure to meet these conditions may result in the loan reverting to the non-discounted APR without further notice. Terms and Conditions are subject to change without notice. *A \$25 processing fee will be charged per eligible payment skipped and cannot be added to the loan. To qualify, your loans must be current and a signed Skip-A-Payment Application with the \$25 fee must be received in our office. Interest will continue to accrue on your loan during the month your payment is skipped. Only one payment may be skipped per year on each eligible loan. Mortgage and Home Equity loans are excluded. For auto loan payments, please check with your GAP insurance carrier to determine how skipped payments may affect your coverage. Other restrictions apply.

Urgent Fraud Message: Scammers Are Pretending to Be PPCU Fraud Department Employees

Several members have received phone calls from cyberthieves posing as employees in Pikes Peak Credit Union's fraud department. In these cases, the caller ID was spoofed to display Pikes Peak Credit Union, but it was not the credit union making the call.

If someone contacts you to request sensitive information, do not share any information and hang up - even if the phone says it's Pikes Peak Credit Union. Don't fall for the fake panic and call us directly at (719) 473-5962 during business hours to verify the authenticity of any requests for sensitive information.
